Specialised education at the heart of the European Union

Our LL.M is aimed at law students who wish to become tomorrow's experts in European law. The one-year program combines both theoretical and practical education, allowing students to acquire a vast understanding of the fundamentals of EU law, and cutting-edge knowledge on current issues. The Faculty is composed of experts from various legal and professional backgrounds: researchers, lawyers, members of the European institutions (EU Commission, Court of justice of the European Union, etc). In order to favour a **qualitative and interactive approach**, admissions for the programme are limited and subject to an assessment by a specialised jury.

Bilingual formation in an international context

In order to emulate the dynamics that characterise the European Union, we welcome students from all over Europe and beyond its borders. Furthermore, our LL.M is **bilingual** in English and French, which means the classes are taught in either language. This is an active choice as both are among the working languages of the different European institutions.

Finally, the LL.M greatly benefits from the cooperation between the Law Faculty of the Université libre de Bruxelles and the **Institut d'études européennes**. Through events and conferences organised by the Institut and the **Centre for European Law**, students have a privileged access to leading experts in the field of EU law.
