SCOPE

The Forum aims to explore the interplay between European Union strategies, policies, instruments or actions, and autocratic politics and governance in the EU's neighbourhood. The Forum will bring together citizens, researchers and experts, including EU and Member States policymakers and civic leaders active in the EU's neighbourhood. Participants will discuss the EU's place in the fight against autocratisation in the EU's neighbourhood by reflecting on the role, instruments, actions, legitimacy, and scope for further intervention to support democracy. More specifically, the Forum will address issues pertaining to the EU's role in supporting counter-autocratisation initiatives, civil society, electoral monitoring and assistance, anti-corruption drives and the defence of judicial independence. Given that citizens are the final 'consumers' of democracy and therefore the final 'beneficiaries' of counter-autocratisation measures, the Forum will place citizens and the EU's capacity to empower citizens to defend democracy at the core of the discussions. Based on the discussions, the event will explore improvements and innovative practices that the EU could adopt to enhance its response in the face of autocratisation dynamics in the EU neighbourhood.
