## History of the EU-Japan Forum

The EU-Japan Forum is an annual meeting of Japanese and European scholars set up to discuss a wide range of topics of shared interest. Except for two years - *i.e.* in 2021 when the conference was canceled due to the global pandemic and in 2022 when it was organized online to accommodate lingering travel restrictions - an in-person gathering has been held in Brussels every year since 1998.

The forum was launched less than a decade after the 1991 “The Hague Declaration” which cemented the formal relations between Japan and the then-European Community. Professors Eric Remacle (IEE-ULB) and Takao Ueta (ICU) organized the first meeting in 1998. It was a seminar entitled “*EU-Japan Interests in a Globalised World*” and helped crystalize a first shared research agenda.



The initial agenda included on the one hand, the many regional challenges the EU was preparing to face at that time - e.g. the introduction of the single currency and enlargement; and on the other, Japan’s response to a changing East Asian environment. These early years of what would become decades-long Euro-Japanese academic dialogue would result in several publications exploring the shifting geo-political realities in Europe and Asia.

In 2007, under the joint direction of professors Takao Ueta (ICU), Mario Teló (IEE-ULB), and Dimitri Vanoverbe (KULeuven), the annual conference was relaunched with a renewed agenda focused on the strategic partnership in the making between the EU and Japan. These meetings would in turn result in a set of publications on the negotiations, implementation efforts, and outcomes associated with the Euro-Japanese Economic and Strategic Partnership Agreements that eventually saw the light of day in 2018.

Two decades after its launch, in 2018, the EU-Japan Forum would again be renewed, this time through a bilateral partnership between the ULB and Waseda. With the support of the Waseda Brussels Office, this most recent period has seen a significant increase in the number of academics as well as disciplines involved in the conference. Besides the continued exploration of the political dynamics shaping the EU-Japan partnership, the Forum has also broadened its scope to include more legal scholarship rooted in international and comparative law as well as research from across the Humanities. In this context, the most recent iterations of the Forum have also enjoyed the support of a JSPS Core-to-Core (C2C) advanced research network based at Waseda University and led by professor Hidetoishi Nakamura named “The European Union and Japan in a Fluid Global Liberal Order: Establishing an Inter-Regional Studies Centre”.

Over nearly two decades and a half, the so-called EU-Japan Forum has grown into the largest academic gathering dedicated to the EU-Japan partnership. It has proven time and again to be a welcome catalyst for the production of original research on a wide range of topics related to the EU and Japan. The body of resulting scientific publications reflects the growing scientific exchanges between scholars on both sides. These fruitful dynamics are set to continue as this year’s forum is to jump-start several new nascent scientific endeavors involving both Japanese and European researchers in the fields of comparative politics, linguistics, cultural studies, and international law.

## Welcome Words

In 2024 the Institut d'études européennes (IEE) of the Université libre de Bruxelles (ULB) will host the 24th edition of its' annual EU-Japan Forum. Between the 4th to the 7th of March, the EU-Japan Forum will once again bring together academics and researchers from across Europe and Japan to discuss a wide range of issues of shared interest.

This year the forum's scientific coordination was again a joint effort between ULB and Waseda scholars. Similarly, the forum's executive committee included both the IEE and the Waseda Brussels Office (WBO). Ultimately, over half a dozen Japanese and European academics were mobilized in the run-up to this year's gathering which is expected to welcome **50 scientific presentations**, with contributors hailing from over a dozen different nationalities, including a delegation of **18 academics and researchers from 12 Japanese universities**.

Past EU-Japan Forums have proven themselves successful research incubators resulting both in joint projects and shared scientific publications across the Social Sciences and Humanities. Bearing this in mind, while seeking to reflect the ever-evolving and expanding agenda of common research interests linking European and Japanese academics, the 2024 EU-Japan forum will seek to broach new research avenues.

In 2024, the forum will include three topical workshops dedicated to nascent joint initiatives, followed by an information session on Japanese research funding opportunities. Each of the three sequentially organized workshops was jointly set up by a specific team of EU- and Japan-based scholars. The respective academic coordinators of the three workshops were brought together by a common interest in jointly exploring a given area of shared interest in the hopes of fostering new Euro-Japanese research outcomes over the years to come.



The first day-long workshop co-coordinated by F. Foret (IEE-ULB) on **Political Narratives in Europe & Asia Compared**, brings together political scientists, sociologists, historians, Japanese and European studies scholars as well as practitioners in a shared effort to explore political narratives on international cooperation in light of Japanese and European Leadership Styles, Higher Education policies, or Collective Memory and Heritage practices

The second two-day-long workshop co-coordinated by S. Detey and N. Morita (SILS-Waseda) entitled **Hate Speech and Abusive Language: Investigation of Verbal Violence, Regulation & Education**, brings together Linguists, political scientists, sociologists, political philosophers, historians, legal scholars, as well as film, Japan and EU studies. 5 disciplinary panels are thus set to unpack the responses to hate speech and abusive language in Europe and Japan in education, public institutions, multicultural societies, modern cinema, as well as political and social media debates.



The final day-long workshop co-coordinated by A. Weyembergh, C. Brière (IEE-ULB), and S. Furuya (Waseda) on **Japanese and European Approaches to International Criminal Justice**, gathers several renowned legal scholars to discuss Japanese and European approaches to international criminal justice.

In a hope to further foster future initiatives between scholars based in Europe and Japan, the 2024 Forum will end with an **information session hosted by the Europe office of the Japan Society for the Promotion of Science (JSPS)** on Japanese avenues of researching funding

# POLITICAL NARRATIVES IN EUROPE AND ASIA COMPARED



Coordinated by professor **François Foret** (IEE-ULB President), the initial one-day Workshop on **Political Narratives in Europe & Asia Compared** will unpack several political narratives that resonate on both sides of the EU-Japan partnership.

Political narratives have become increasingly salient in contemporary politics, from the “nation-branding”, the search for “soft power” or the framing of conflicts in external affairs, to the conflictualization of identities and values in the internal public spheres. This proliferation and quick obsolescence of narratives can be interpreted as an outcome of political disenchantment and secularization. Many stories compete – “in real life” or in digital media – to fill the void left by the erosion of “big narratives” (e.g., ideologies, nations, religions). The tensions, hybridizations, and clashes between narratives are all the more important in diversifying and individualizing societies and in multilevel systems of governance.

While narratives express historical, social, and cultural specificities, they also circulate worldwide and are shaped by global trends. To avoid essentialism, they must be analyzed both in their context of enunciation (polity/policy sector) and through a comparative prism. Building on previous work, this is what this workshop sets out to do on narratives about **leadership, education, and the past**.

# HATE SPEECH AND ABUSIVE LANGUAGE

## THE INVESTIGATION OF VERBAL VIOLENCE, REGULATION AND EDUCATION



Coordinated by professor Sylvain Detey (Waseda University - Tokyo), the workshop **Hate Speech and Abusive Language: The Investigation of Verbal Violence, Regulation, and Education** aims, through a multiplicity of angles, to shed some light on the complexity of contemporary “verbal violence” and, maybe, to offer some suggestions as to how to look for a solution to the problems it creates.

For quite some decades “hate speech” and “abusive language” used to be envisaged as abnormal linguistic behaviors targeting specific communities or individuals, and, according to the context, deemed either socially undesirable in the public sphere or straightforwardly illegal. However, with the rapid development of SNS on the one hand, and the multifaceted impact of globalization on the other hand, the complex evolution of what could be termed “verbal violence” has come to affect many spheres of our normal lives, whether it is perceived through a certain form of hypersensitivity or hyposensitivity. Whether it is turned into cyberharassment, verbal assault, disinformation, or political maneuver, it is now affecting not only all sorts of minorities but also all children’s and citizens’ social well-being. They are not easy and simple issues to deal with because not only linguistic, cultural, educational, and social, but also ethical, political, and ideological factors involving censorship, regulation, and freedom of speech and expression are involved.

International criminal justice is an active field of international cooperation. States actively negotiate, conclude, and implement international agreements to facilitate the prosecution of international core crimes by specialized tribunals and courts, such as the International Criminal Court. Concomitantly, States also intensely cooperated to combat transnational serious crimes, especially those committed by organized criminal groups.

European countries and Japan have been particularly engaged in these international initiatives. Since the early 1990s, the EU has emerged as a key actor, often in concert with either regional or global initiatives, as well as in support of bilateral partnerships with non-EU countries. Japan is also a driving force behind international efforts to ensure accountability. It is for example not only party to the Rome Statute, but also the highest single contributor to the ICC. It is also one of the few countries that agreed to conclude a bilateral treaty on mutual legal assistance with the EU, opening doors for closer cooperation in criminal matters. If Europeans and Japanese have been particularly engaged, they have nonetheless maintained distinct approaches.

## Workshop on European and Japanese Approaches to International Criminal Justice

The two roundtables are based on a book project that seeks to offer a new perspective on European and Japanese approaches to international criminal justice. Contributors are invited to conduct a transversal analysis examining the respective positions of the EU and Japan towards international criminal justice, and how the two partners build on their existing collaboration to promote international criminal justice. Exchanges are to help pinpoint similarities and/or divergences in the respective approaches. Singularly, all contributions are jointly written by EU- and Japan-based scholars thus combining their expertise.

## Academic Coordinators



**Dr. Paul Bacon** is a tenured Professor of International Relations and a Jean Monnet Chair at the Faculty of International Research and Education, Waseda University, Tokyo. His research interests include the SDGs, human security, the EU, EU–Japan relations, liberal international order, and human rights norm diffusion. Bacon has published four co-edited Routledge monographs: *The European Union and Japan: A New Chapter in Civilian Power Cooperation?*; *Human Security and Natural Disasters*; *Human Security and Japan’s Triple Disaster* (all in 2016); and *The Sustainable Development Goals: Diffusion and Contestation in Asia and Europe*, in 2023. He has published many articles, in leading and respected academic journals such as *Journal of Common Market Studies*, *Asian Security*, and *International Relations of the Asia-Pacific*. He is currently working on a Jean Monnet Network project on the critical reception of the EU Indo-Pacific Strategy in several key Indo-Pacific states. He is also working on a JSPS Kakenhi project with colleagues from the University of Tokyo which focuses on the EU and FIMI (foreign information manipulation and interference).

**Chloé Brière** is a professor of EU law at the Centre for European Law and an affiliated member of the IEE (Université libre de Bruxelles). Since 2019, she has been holding the chair in European law, teaching, researching, and supervising students in the Faculty of Law and Criminology. She is an active member of the Centre de Droit Européen (CDE), which she was the director of till September 2023 when she became director of the Institut d’études européennes (IEE). Her doctoral research focused on the European legal framework concerning the fight against Trafficking in Human Beings and its promotion outside the European Union’s borders. Her research interests include other aspects of European Union Law, such as EU Criminal Law, EU external relations law, EU migration law, and the free movement of persons.



**Sylvain Detey** (PhD and HDR in Linguistics) is Professor of Applied Linguistics and French Studies in the School of International Liberal Studies (SILS) and Vice-Dean of the Graduate School of International Culture and Communication Studies (GSICCS) at Waseda University (Tokyo, Japan). He was formerly Maître de Conférences en Sciences du Langage in the Department of Linguistics and Communication at the University of Rouen (France), and he has lived and taught in France, in the UK, and in Japan. He is the co-director of the international research program Inter-Phonology of Contemporary French, and an appointed member of the Scientific Committee of the Observatory of Linguistic Practice of the Délégation Générale à la Langue Française et aux Langues de France (French Ministry of Culture). In 2023, he was awarded the title of Knight in the Order of the Academic Palms by the French Republic. He has widely published in applied linguistics and given more than 150 presentations in 20 countries. He specializes in Second language education, Applied phonology, and Corpus-based sociolinguistics, and he has co-edited *Les variétés du français parlé dans l’espace francophone* (Ophrys, 2010), *La prononciation du français dans le monde: du natif à l’apprenant* (CLE international 2016) and *Varieties of Spoken French* (Oxford University Press, 2016). In 2023, he published his first monography in French *Savons-nous vraiment parler? Du contrat linguistique comme contrat social* (Armand Colin) which was cited in top French newspapers (Le Monde, Le Figaro, Ouest France, L’Express, Le Français dans le monde, Le Français aujourd’hui, The Conversation).

**François Foret** is Professor of political science and researcher at the Cevipol and the Institute for European Studies (IEE), Université Libre de Bruxelles; and President of the IEE-ULB (from september 2023). He is also a fellow at the European Governance and Politics Programme, Robert Schuman Centre, European University Institute Florence. His specialization is in political sociology; European studies and comparative politics. His researches focus on the legitimization of political orders; symbolic politics; the interaction between politics, culture, religion, and values; and the comparison between Europe, Japan, and the US. His current research project deals with the proliferation and rapid exhaustion of political narratives in processes of community- and polity-building. The purpose is to understand to which extent and how identity, normative, and memory issues are recycled into new cultural forms and interact with the justification of public institutions. The evolution of narratives across time and space is analyzed in its relation to political, economic, and technological change.



## Academic Coordinators



**Shin Matsuzawa** is Professor of Criminal Law at the School of Law, Waseda University, Tokyo, Japan. He is also member of the Board of Directors of the Japanese Society of Criminal Law. His main research interests are in the methodology of criminal law and the comparative law of Scandinavian and Japanese criminal law. He has recently expanded his research interests to include the basic theories of criminal law and has conducted significant research in the areas of criminalisation and punishment theory. Most of his work has been published in Japanese, but he has also recently published articles and books in English. His most notable work is a co-edited volume, *Methodology of Criminal Law Theory* (Nomos/Hart 2021), based on his keynote lecture at an international symposium. Matsuzawa has presented at the American Society of Criminology and the International Society for the Study of Law and Society, and has given many lectures at universities in Asia (China) and Europe (Scandinavian countries and Germany).

**Norimasa Morita** obtained his BA and MA degrees at the Faculty of Letters, Arts and Sciences of Waseda University, majoring in English literature, and acquired his second MA at the University of Kent. Completing all coursework for Ph. D. at Kent in 1985, he earned his Ph. D. in English in 1990. His specialty is film studies (world cinema) and comparative literature (world literature).

Morita joined Waseda in 1986 as a lecturer and became a professor in English and film studies in 1997. Since 2004, he has been teaching in the School of International Liberal Studies (SILS) and since 2013, at Graduate School of International Culture and Communication Studies (GSICCS). He served as Dean of SILS between 2010 and 2014 and as Vice-President of International Affairs between 2014 and 2018.

He teaches film studies at SILS and GSICCS and literary theory at the Graduate School of Letters, Arts and Sciences. His publications include monographs such as *Marginalia: Hiding Literature and Hidden Literature*, *Britain and Japan: Biographical Portraits*, and *World Literature/Japanese Literature* and edited books, *Japan beyond Borders: Transnational Approaches to Film and Media* and *Japanese Transnational Cinema* (both co-edited with Marcos Centeno Martin).



**Furuya Shuichi** is a dean and professor of international law at Waseda Law School, Tokyo. He was a member of the UN Human Rights Committee (2019-2022, Vice-Chair 2021-2022), a member of the International Humanitarian Fact-Finding Commission (2012-2021, Vice-President 2015-16), Co-Rapporteur of the ILA Committee on Reparation for Victims of Armed Conflict (2004-2014), and the editor-in-chief of *Journal of International Law and Diplomacy* (2014-2016). He has published many articles in English and Japanese on international criminal law, humanitarian law and human rights law, including the topics of reparation for victims of armed conflicts and the participation of victims in international criminal justice. He has recently edited a book: *Global Impact of the Ukraine Conflict: Perspectives from International Law* (Springer, 2023).

**Anne Weyembergh** graduated in Law (ULB, 1993 – 1st Class Honours). She holds a Masters Degree in Public and Administrative Law (ULB, 1994 – 1st Class Honours) and a Masters Degree in International Law (ULB, 1995 – 1st Class Honours). She has completed a PhD in Law at the ULB (2003 – Alice Seghers Prize).

She is a full time Professor at the ULB (Faculty of Law and Institute for European Studies). Together with Serge de Biolley, she founded the European Criminal Law Academic Network (ECLAN) in 2004. She has been co-ordinating the Network (with Valsamis Mitsilegas and Katalin Ligeti) since then.

She is presently the Vice-rector of the ULB charged with external relations. Previously, she has been President of the Institute for European Studies of the ULB since October 2014. In addition, she is the coordinator of the team on European criminal law (Centre for European Law). Professor Weyembergh has been the Chief Editor of the *New Journal of European Criminal Law* (with Paul De Hert, Valsamis Mitsilegas, Scott Crosby and Holger Matt) since May 2014. She has also been General Editor of the EU Criminal Law series of Hart Publishing (with Valsamis Mitsilegas and Katalin Ligeti) since 2014 and Member of the Comité de rédaction des Cahiers de droit européen.



## Organising Committee

**Jean-Louis Moortgat** is, since 2017, Director of the Waseda University Brussels Office for Europe. Since 2008, he is also International Senior Officer in charge of ULB's relations with Asia. In this capacity, he was project director for the EuropeAid project: "Promoting appropriate technologies for small-scale farmers to increase food security for indigenous populations in Cambodia and Laos" (2013 - 2015). Prior to this, Jean-Louis Moortgat was successively: ULB - Deputy Secretary General (1990-1998); Budget Advisor to the Minister of Culture and Continuing Education, French-speaking Community of Belgium (1998-1999); Responsible for evaluating the quality of university education for the Council of Rectors, French-speaking Community of Belgium - CReF (1999-2002); Advisor to the Cabinet of the Government Delegate to the ULB (French-speaking Community of Belgium) (2002-2003); Administrative and Financial Director of the Museum of Contemporary Art (MAC's) of the French-speaking Community of Belgium (2003-2008).



**Frederik Ponjaert** is a researcher at the Institute for European Studies at Université libre de Bruxelles (ULB) and Assistant Lecturer in Comparative Regionalism at SciencesPo (IEP-Paris). His research is on comparative regionalism, with an emphasis on European and Asian realities. He equally works on EU external action and inter-regional partnerships, again with a specific focus on Euro-Asian dynamics. More recently, both of these research strands have focussed on the developing EU-Japan relationship in light of the recently signed Economic Partnership and Strategic Partnership Agreements. His teaching covers topics such as "comparative regionalism", "EU external action" and "EU-East Asian Relations" as well as "Japanese Foreign Policy. At the ULB, he is a member of both the Institut d'Études Européennes (IEE) and the East Asian Studies Center (EASt). He is also the scientific coordinator of the GEM Ph.D. School on "Globalisation, the European Union and Multilateralism". He is also co-editor of two Routledge book series: the GEM series on 'Globalisation, Europe and Multilateralism' and the CES series on "Contemporary Asian Societies".

## Speakers



**Andrea Apollonio** is a PhD candidate in Social and Political Change at the Universities of Turin and Florence. His research interests include political practices and narratives surrounding historical memory, with a focus on European and Japanese contexts. Having conducted fieldwork in Okinawa, Andrea Apollonio investigated the political narratives constructed and employed within the anti-militarist movement in the Japanese prefecture. Presently, his research delves into the socio-political dynamics shaping the discourse on "European historical memory" within the European Parliament.

**Laure Baudrihaye-Gérard** is Legal Director (Europe) for Fair Trials, the criminal justice watchdog, Laure leads Fair Trials' legal and policy work in Europe and the organisation's engagement with European regional authorities. She also leads on projects and strategic litigation in regional and domestic courts. Laure studied English and French law (at King's College London and the Université de Paris I, Pantheon-Sorbonne) and EU law at the College of Europe (Bruges). Laure qualified as a Solicitor in England & Wales in 2006 and represented and advised clients in relation to competition law investigations and other EU law-related disputes (in both London and Brussels). Laure then qualified as a criminologist (Université Libre de Bruxelles, 2016) and published research on the Belgian criminal justice system. Since 2019, Laure actively participates in volunteer monitoring activities in a Brussels prison (including since 2020 as President of the Commission des plaintes of the prison of Saint-Gilles, a newly established jurisdiction in Belgian prisons to hear the appeals of detainees against decisions of the prison administration)



**Nicolas Baygert** is a scholar in the field of political communication, holding dual PhDs in Information and Communication Science from CELSA (Paris-Sorbonne) and from the Catholic University of Louvain (UCLouvain). He is also the holder of a DEA in Political Science from the Catholic University of Louvain, a Master of Arts in International Relations from the University of Kent, and a Master's degree in public relations from UCLouvain. Nicolas Baygert is affiliated with institutions such as Sciences Po Paris, Université Libre de Bruxelles (ULB), and the Institute for Higher Social Communication Studies (IHECS), where he leads PROTAGORAS, a Think Tank dedicated to political and public communication. His professional journey encompasses roles in public affairs, including positions at a Think Tank (CEPS), a communication and public affairs agency, and the European Commission as a communication officer. In more recent years, he has engaged as an external consultant, providing strategic counsel on institutional communication and public affairs.

**Olivier Bertrand** is a university professor. He holds a Doctorate (Sorbonne Nouvelle) and an Habilitation to supervise research (HDR), he has been teaching at the École polytechnique since 2003 and was vice-president from 2006 to 2009, then president of the Department of Languages and Cultures from 2011 to 2017. Specialist in medieval French, philology and history of the French language, he is a member of the Research Laboratory "Lexiques, Textes, Discourses, Dictionaries" and professor of historical linguistics and medieval lexicography at CY Cergy Paris University since 2012, where he was successively Director of the French Center (2013-2014), Director of the Department of Modern Letters (2014-2015), Research Project Manager (2015-2016) then Vice-President Research of the University from 2016 to 2018. Olivier BERTRAND is an ERC laureate for European Research (2009-2013), CNRS bronze medalist (2011) and Knight of the Academic Palms (2017). Lecturer at Sciences Po Paris, at the Ecole des Mines and at ENSTA Paris, he is a member of the jury of the external Capes of Modern Letters, and vice-president of the jury of the external Agrégation of Modern Letters (2014-2017). He is also a member of the jury for the entrance examination to École polytechnique and ENS ULM (series B/L).



## Speakers



**Julia Burchett** is a postdoctoral researcher (F.R.S.-F.N.R.S.) affiliated with the Centre for European Law. Having obtained her PhD in October 2021, she dedicated her thesis to “The European Union and the Fight Against Radicalisation”, conducted as part of a joint supervision between the Université de Grenoble-Alpes (France) and the Université Libre de Bruxelles (ULB). Her work was honored with the 2022 Thesis Academic Thesis Award from the University of Grenoble-Alpes. Her research primarily focuses on European criminal law. Following the completion of a postdoctoral research on the right of victims of cross-border crimes (2021-2023), she is currently conducting a postdoctoral research addressing the EU’s response to the war in Ukraine and the fight against impunity for serious international crimes. Having started her teaching career as a teaching assistant in EU law from 2017 to 2019, she has been responsible for teaching the course “EU Criminal Law” since 2022 and actively participates in mentoring students within the framework of the European Criminal Law Clinic, coordinated by Prof. Anne Weyembergh. In addition to her research and teaching activities, Julia is actively involved in the daily management of the Academic Network of European Criminal Law (ECLAN).

**Laura Calabrese** holds the Chair of Multilingual Communication in the Department of Information and Communication Sciences at ULB. She teaches discourse analysis and sociolinguistics and specializes in political and ordinary discourse on digital media and social networks. She has published numerous articles on media events, ordinary discourse on web platforms, semantic controversies, discourse on race, diversity, Islam, and migration, as well as the books *The Event in Discourse* (2013) and *Thinking about words, Saying Migration* (2018) with Marie Veniard. She led an FNRS project on “The image of Islam and Muslims in the French-speaking Belgian press” and the ARC Communication work package “Untangling the multiple categorizations of migrants”. She regularly collaborates with civil society associations on themes linked to racism, diversity, and migration.



**Anemona Constantin** is a political sociologist by training. She holds a Ph.D. in political science from the University of Paris Nanterre (2019), where she taught seminars in political science and social history of ideas for MA and BA students (2006-2011). Her works examine the transformations of the Romanian intellectual field after 1989, the public debates around the political past that sparked in Eastern Europe during the post-socialist period, and the (re)-writing of national histories after the fall of the Berlin Wall in Romania, Bulgaria, and the Republic of Moldova.

**Natsuko D'Aprile** is a PhD student in political science at the Center for the Study of Political Life (CEVIPOL) of the ULB and Aspirante FNRS, my thesis project is entitled “France and Japan, two public diplomacies in comparison (1990-2022), or how the construction of the Nation conditions its promotion”. After a master’s degree in political science and international relations at ULB during which I compared the cultural diplomacies of these two countries (with language and religion as objects of study), my objective today is to understand the way whose historical construction over the long term of these two Nations influences the promotion of their national identity. To do this, I will first establish a map of the two public diplomacies, and I will then focus on their narrative practices, to understand what image of the Nation these two countries project.





## Speakers

**Guibourg Delamotte** is a French and Australian dual citizen, Guibourg Delamotte is a tenured Full-Professor of Political Science at the Japanese studies department of the French Institute of Oriental Studies (Inalco), of which she is presently the Head and a Research Fellow with the French Research Institute on East Asia (Inalco/CNRS). She is a Distinguished Research Fellow of the Japan Forum on International Relations (JFIR, Tokyo) and an Academic Fellow of the Institute for Contemporary Asian Studies (Temple University Japan, Tokyo). From 2021 to 2023, she was also invited by the University of Tokyo's Research Centre for Advanced Science & Technology. She was a National Institute of Defense Studies Fellow (Tokyo) in 2010. She works on Japan's foreign and security policies and Japanese domestic politics. She most recently published *Le Japon, un leader discret* (Eyrolles, 2023), *La Démocratie au Japon, singulière et universelle* (ENS Ed., 2022), and coedited (with J. Brown and R. Dujarric) *The Abe Legacy. How Japan has been shaped by Abe Shinzô*, Lexington, 2021; *Géo-politique et géoéconomie du monde contemporain. Conflits et puissances* (with C. Tellenne), La Découverte, 2021.



**Martin Deleixhe's** main research interests are located at the crossroads of democratic theory, migration, and border studies. He also has a keen interest in European studies and in the history of political thought, with an emphasis on the history of democratic theory. He is currently an associate professor in the Department of political science at Université Libre de Bruxelles.

**Asuncion Fresnoza-Flot** is an FNRS qualified researcher at the Laboratory of Anthropology of Contemporary Worlds (LAMC) and is currently working on Belgian-Asian couples (BelMix) and on the decision-making process of so-called "Asian" people aspiring to (re) migrate to/within the EU (AspirE). She is also a lecturer and teaches the courses "Migration and gender" (GENR-D401) and module 1 "Intermarriages, 'mixed' families and migration" of the Anthropology Seminar 1 (SOCA-D307). His recent work includes the special issue "Challenging stereotypes in Europe-Thailand transnational migration" (with S. Sunanta, *Advances in Southeast Asian Studies*, 2022) and the collective work *Tangled mobilities. Places, affects, and personhoods across social spheres in Asian migration* (with G. Liu-Farrer, Berghahn 2022).



## Speakers

**Mona Giacometti** is a professor of criminal law at ULB. She obtained this position in October 2023. She is also an attorney at law, member of the Brussels Bar, since 2011. Mona Giacometti's research focuses on technological developments in criminal law, both in terms of new criminal phenomena committed online and in terms of the investigative techniques that are being developed on the Internet or thanks to the cooperation of communication service providers. Between 2021-2023, she carried out post-doctoral research as part of the antidote project on cyber-violence : defining borders on permissibility and accountability. She obtained a PhD in 2020 (supervisor : Prof. Dr. Marie-Aude Beernaert). The topic of her doctoral research focused on the collection of electronic evidence in European context. She envisaged the construction of a model in the light of a new conception of state sovereignty. Her thesis has been published in 2023 by Larcier. In addition to her doctoral research, Mona Giacometti regularly writes articles and contributions on subjects relating to criminal procedure and criminal law. She is also a member of the editorial boards of the law journals "Journal des tribunaux" and "Revue de droit pénal et de criminologie".



**François Heinderyckx** is a full professor at the Université libre de Bruxelles (ULB), where he teaches media sociology and political communication. He is an advisor to the Rector of the ULB for the European University Alliance CIVIS. He is Series Editor in chief of the Wiley Blackwell - ICA International Encyclopedias of Communication. He is a member of the Academia Europaea and a Fellow of the International Communication Association. He was Dean of the Faculty of Letters, Translation, and Communication at ULB (2015-2019), Visiting Scholar at the Columbia University Graduate School of Journalism (2019-2020), and a Chang-Jiang Scholar Professor at the Communication University of China, Beijing (2013-2018). He was President of the European Communication Research and Education Association (ECREA) from 2005 to 2012. He was also the 2013-2014 President of the International Communication Association (ICA)

**Kodai Hashimoto** is an Associate Professor of Criminal Law at Nanzan University, Nagoya, Japan. He received his Ph.D. in Law at Keio University, Tokyo, Japan for a thesis on the role of criminal law in combating transnational organized crime. He is a qualified FATF (Financial Action Task Force) Assessor and has already been involved in some FATF ME (Mutual Evaluation)s. He contributed to the FATF 4th round ME of Germany as an Assessor (targeted financial sanctions expert). In addition, he has contributed to the Elgar Encyclopedia of Crime and Criminal Justice as the author on Japan.



**Sonya Imin** is a Uyghur American doctoral researcher and multi-disciplinary creative based at Université libre de Bruxelles. Her research project explores how transformations in Uyghur exile are being negotiated through visual art and contemporary creative culture. Specifically, her project focuses on how diasporic identities are being articulated, how cultural shifts are being heightened by the realities of exile and genocide, and what narratives are being addressed through Uyghur creative arts. By looking at the dialogues around Uyghur art practices in diaspora, her research hopes to delineate specific shifts of perception and experience, areas of alignment and integration, strategies of resistance and (non)disclosure. In addition to her academic work, Sonya is one of the co-editors of the Contemporary Uyghur Anthology, a multi-lingual collection of Uyghur art, poetry, and prose. She is also working on various forthcoming art and film projects spanning across the US, Europe, and Central Asia.

She stayed at Max Planck Institute for Comparative Public Law and International Law (Heidelberg, Germany, 2008, 2010), Max Planck Institute for Foreign and International Criminal Law (Freiburg, Germany, 2011) and Harvard Law School (Cambridge, the United States, with Fulbright Scholarship, 2014-15) as a guest researcher.



**Yoshisuke Ito** is an associate professor at the Faculty of Law of Hiroshima Shudo University. He from graduated from the doctoral program at the Department of Public Law of the School of Law at Waseda University. His field of specialization is criminal law and his major research themes are the Theory of complicity, crimes of conspiracy, as well as AI/robots, and law.

Having studied law at the University of Athens (LLB) and the ULB (LLM), **Vaios Koutroulis** received his PhD in 2011 for a thesis on the relations between jus contra bellum and jus in bello. He is currently a professor of public international law at the Faculty of Law of the Université libre de Bruxelles (ULB). His courses include the law of armed conflict, international criminal law, public international law, and international environmental law. His publications focus mainly on jus in bello and jus contra bellum and include a monograph on belligerent occupation published by Pedone editions (Paris) in 2010. Vaios Koutroulis was an adviser to the Counsel and Advocate of Belgium in the case concerning Questions relating to the Obligation to Prosecute or Extradite (Belgium v. Senegal) before the International Court of Justice.



**Adam Lazowski** is a Professor of EU law at the Westminster Law School, University of Westminster. 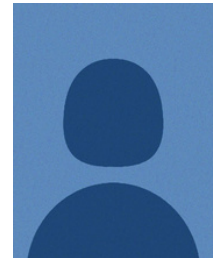
## Speakers

**Joachim Scharloth** is a linguist and Professor of German Studies at Waseda University in Tokyo. He does things with computers to understand changes in communication and society with the help of textual data analysis. His research interests include political communication, the language of political extremes and social movements. He is particularly interested in the question of how specific modalities of interaction are used to generate attention and cultural hegemony. His book "1968. Eine Kommunikationsgeschichte" ("1968. A History of Communication", 2011) dealt with anti-rituals of protest. The subject of his latest book "Hässliche Wörter. Hate speech als Prinzip der Neuen Rechten" ("Hateful Words", 2021) deals with linguistic forms of degradation in right-wing online media.
